### **2014 New Mexico Legislative Session is Underway**

The 51<sup>st</sup> Legislature of the State of New Mexico opened on January 21, 2014, for a thirty-day session. During the first half of the session, at least 20 bills and memorials related to disability issues were introduced. Subject matter included Medicaid, education, autism, and other developmental disabilities. ### **Two Action Alerts Issued**

It's time to act! During the second week of the legislative session, the PLAN issued two Action Alerts for bills concerning the DD waiver program and funding for autism services:

#### **DD waiver – SB 55 (Sen. Bill Soules)**

This bill would require the Department of Health and the Human Services Department to develop a 5-year plan to address the DD waiver waiting list, and would appropriate additional funding to serve individuals on the waitlist. (The bill originally called for \$25 million in the upcoming fiscal year; it was amended to reduce the amount to \$10 million.) The bill passed the Senate Public Affairs Committee and is pending in the Senate Finance Committee. Click [here](#) to contact Senate Finance Committee members and express your support for SB 55.

#### **Autism services –**

#### **HB 69 (Rep. Liz Thomson) and SB 109 (Sen. Lisa Torracco)**

These identical House and Senate bills would appropriate \$350,000 for autism services. SB 109 has already passed the Senate Public Affairs Committee and is now pending in the Senate Finance Committee. Click [here](#) to contact Senate Finance Committee members to express your support for SB 109.
